- \* MOTION to elect Vice Chairwoman McGee to serve as Vice Chairperson of the BPAC for 2019. Carried UNANIMOUSLY
  - 6b. Transportation Alternatives Program (TAP) 2019 Grant Applications: Review and prioritization of the TAP grant applications for the 2019 grant cycle.

Mr. Buchwald summarized the types of projects for which TAP funding may be used and explained how and when the \$679,339 of funding available to the St. Lucie TPO for the 2019 grant cycle would be programmed. He detailed two TAP grant applications that had been submitted for consideration for the 2019 cycle, the Selvitz Road Sidewalk Project and the Bell Avenue and Sunrise Boulevard Sidewalk Project, and indicated that the Selvitz Road Project had been ranked higher according to the Transportation Alternatives (TA) Project Prioritization Methodology. Because of that ranking, Mr. Buchwald explained further, it was recommended that the Selvitz Road Project be prioritized for funding above the other project, with the Bell Avenue and Sunrise Boulevard Project receiving the remainder of the TPO's TAP funding for 2019 along with any excess TAP funding allocated by FDOT District 4 for 2019.

In response to Mr. Love's question, Mr. Buchwald clarified how the grant funding would be distributed between the two projects.

- \* MOTION by Mr. Love to recommend the prioritization of the TAP grant applications for the 2019 grant cycle as presented.
- \*\* SECONDED by Vice Chairwoman McGee Carried UNANI MOUSLY
  - 6c. Automated/Connected/Electric/Shared-Use (ACES) Vehicles for Transit Study: A presentation of the ACES Vehicles for Transit Study.

Mr. Buchwald noted the growing prominence of ACES vehicles within the transportation industry and the resulting task dedicated to the subject in the TPO's Unified Planning Work Program (UPWP) before inviting Ms. Lathou to provide the presentation. Ms. Lathou began by defining ACES and describing how such "new mobility" would be incorporated into the ten-year Transit Development Plan. She shared some industry forecasts for driverless vehicles, gave examples of various levels of automation, and described the current and potential use of ACES technology within the transportation industry. Ms. Lathou outlined a number of public agency responses to ACES, focusing particularly on the recommendations of the St. Lucie County New Mobility Study, and then explained the recommendations for how the TPO might offer implementation assistance.

Ms. Thompson inquired about the absence of safety concerns from both the report and the presentation. Ms. Lathou clarified that the recommendations presently under consideration only pertained to whether the TPO should assist with facilitating transit automation; safety concerns would be discussed during future stakeholder meetings.

In response to Mr. Love's question, Ms. Lathou elaborated on the recommendation concerning public awareness and education.

Chairman Gilmore asked if the topic of liability were being discussed, and Ms. Lathou affirmed that the issue was being addressed by the ACES industry.

- \* MOTION by Mr. Love to recommend the selected recommendations in the ACES Vehicles for Transit Study for implementation assistance by the TPO.

Carried UNANI MOUSLY

6d. South Causeway Bridge Reconfiguration Project: Review of the proposed South Causeway Bridge Reconfiguration Project and the Preferred Alternative and the plan for its reconsideration.

Mr. Buchwald indicated that the TPO Advisory Committees had previously requested that the issue of adding bicycle lanes to the South Causeway Bridge in Fort Pierce be re-examined by the TPO Board and that, consequently, it was necessary to make a recommendation for the Board to consider at its February 2019 meeting. Mr. Buchwald gave a brief history of the issue, describing its past reception by local agencies and community members, and explained that concerns about safety and potential congestion had prevented the reconfiguration from going forward in 2012. He presented a number of conceptual plans that had been produced by the 2012 South Causeway Bridge Reconfiguration Study and explained that each alternative would reduce the number of travel lanes from four to two and maximize the bicycle and pedestrian accommodations without reducing vehicular service. Mr. Buchwald outlined the recommended public input plan and concluded with the suggestion that a Preferred Alternative be selected.

In response to Mr. Davis' question, Mr. Buchwald clarified that the alternative being recommended by TPO staff was the one presented in the South Causeway Bridge Reconfiguration Study as the Preferred Alternative/Exhibit 5, which would preserve the existing pedestrian lanes and concrete barriers while converting the two outside travel lanes to bicycle lanes through re-striping. He summarized some benefits of this configuration, noted the possibility of implementing it in stages, and commented on its likelihood of success relative to the other alternatives.

Mr. Smitsrod inquired about the future capacity needs of the bridge, and Mr. Buchwald explained that there is not expected to be significant growth on South Hutchinson Island because of the existing land use policies.

A discussion ensured regarding connectivity, with Mr. Davis remarking on the high quality of the bicycle accommodations on the rest of South Hutchinson Island. Ms. Thompson commented that bicyclists may also want to connect to the SunTrail to the north.

In answer to Vice Chairwoman McGee's question, Mr. Buchwald clarified that the public opinion survey would be administered on the TPO's website. He mentioned that CAC members would be attending upcoming meetings to speak in support of this item and urged BPAC members to do the same.

Mr. Wallace asked whether the proposal to eliminate lanes had been approved by FDOT, and Mr. Buchwald explained that the proposal had not yet been approved to move forward by the TPO Board.

In response to Vice Chairwoman McGee's request for feedback on cyclists' preferences for shared-use lanes versus dedicated lanes, Mr. Davis shared his personal preference for dedicated lanes and the need for barriers in addition to dedicated lanes at narrow situations such as bridges with no margin for error.

Ms. Thompson initiated a discussion regarding the use of buffer lanes to separate bicycles from cars, commenting that cyclists sometimes used the buffer lane rather than the dedicated bicycle lane. Mr. DeFronzo remarked that cars routinely drift into adjacent lanes, suggesting that barriers might better alleviate those safety concerns.

#### BACKGROUND

The Florida Department of Transportation (FDOT) is developing a Multimodal Master Plan for the segment on I-95 from the Palm Beach/Martin County line to the Indian River/Brevard County line, a distance of approximately 71 miles. The Plan is an integral part of the continuing process for the development of the Strategic Intermodal System (SIS) and in reaching overall regional mobility goals through short and long-term capacity and operational improvements. The expected completion of the plan is December 2019.

#### <u>ANALYSIS</u>

The St. Lucie Transportation Planning Organization (TPO) Staff has participated in the development of the I-95 Multimodal Master Plan to ensure that the proposed improvements eventually recommended by the Plan are consistent with the TPO's plans and programs and the vision of the TPO Board. Staffs from the local municipalities and St. Lucie County also have participated in the development of the Plan.

As potential improvements to I-95 within the TPO area have been identified by the I-95 Multimodal Master Plan Team, it is appropriate for these improvements to be reviewed by the TPO Advisory Committees and recommendations be provided to the TPO Board based on the review of the improvements. Therefore, FDOT will present the Plan to the advisory committees that includes the improvements for review.

#### RECOMMENDATION

It is recommended that the I-95 Multimodal Master Plan by FDOT be reviewed, and the proposed improvements be recommended based on the review.



#### BACKGROUND

A Transit Development Plan (TDP) is required by the Florida Department of Transportation (FDOT) for the receipt of funding through the Public Transit Block Grant Program. A TDP is the public transportation provider's planning, development, and operational guidance document and is based on a 10-year planning horizon. A Major Update is required every five years. Annual updates in the form of progress reports on the 10-Year Implementation Program of the TDP also are required.

In St. Lucie County, the Board of County Commissioners (BOCC) contracts with Community Transit, a division of the Council on Aging of St. Lucie, Inc., for public transportation services. The St. Lucie County TDP Major Update is endorsed by the TPO Board and adopted by the BOCC.

Task 3.2 of the St. Lucie Transportation Planning Organization (TPO) FY 2018/19 – FY 2019/20 Unified Planning Work Program (UPWP) includes activities related to the provision of technical and planning assistance to the transit provider in order to maintain the BOCC's eligibility for the continued receipt of Federal and State transit funds. These activities include support of the TDP Major Update and Annual Progress Reports.

#### ANALYSIS

The TPO and St. Lucie County initiated the TDP Major Update process in August 2018. The project's extensive public outreach includes focus groups, surveys, and community meetings. Staff's presentation to the TPO Advisory Committees will focus on the transit service improvements listed below and shown on the attached map.



#### BACKGROUND

The development of the Greater Treasure Coast Regional Planning Model (GTCRPM), which is an activity-based travel demand model, and the development of the Long Range Transportation Plan (LRTP) for the St. Lucie Transportation Planning Organization (TPO) both utilize population projections to forecast future growth, traffic volumes, and transportation needs. The 2045 updates for the GTCRPM and the LRTP will utilize a population projection for St. Lucie County for 2045.

The Bureau of Economic and Business Research (BEBR) at the University of Florida produces Florida's official State and local population estimates and projections and has been making population projections for Florida and its counties since the 1970s. These estimates and projections are used for distributing state revenue-sharing dollars to cities and counties in Florida and for budgeting, planning, and policy analysis by State and local government agencies, businesses, researchers, the media, and members of the general public.

To account for uncertainty regarding future population growth, BEBR publishes three series of projections for future years. For 2045, BEBR has published the following three population projections for St. Lucie County:

Low:	360,400
Medium:	431,200
High:	525,100

BEBR believes the medium series is the most likely to provide accurate forecasts in most circumstances, but the low and high series provide an indication of the uncertainty surrounding the medium series. It should be noted that these projections refer solely to permanent residents of Florida, and they do not include tourists or seasonal residents.

Another population projection for 2045 for St. Lucie County results from the extrapolation of the population projection for 2040 from the Go2040 LRTP. This methodology projects a 2045 population of 483,841 for St. Lucie County. It is requested that the four potential population projections be reviewed and a recommendation for a projection for the 2045 population in St. Lucie County be provided to the TPO Board.

#### <u>ANALYSI S</u>

The following table summarizes the actual populations and growth rates in the adoption years of the last five LRTPs of the TPO and the projected populations and growth rates used in those LRTPs:

As indicated in the table, the actual average annual growth rate of population in St. Lucie County from 1995 to 2017 is 2.36 percent, and the total average of the projected growth rates used in the LRTPs is 2.41 percent.

The average annual growth rates from 2015 to 2045 for the potential 2045 population projections are as follows:

#### RECOMMENDATION

Based on the projected average annual growth rate of the BEBR High Projection most closely approximating the actual average annual growth rate of population in St. Lucie County from 1995 to 2017, it is recommended that the BEBR High Projection of 525,100 be recommended to the TPO Board as the 2045 projected population of St. Lucie County.

#### BACKGROUND

One of the tasks of the Unified Planning Work Program of the St. Lucie TPO is Task 3.5 – Complete Streets Planning. The purpose of this task is to review, update, and implement the St. Lucie Walk-Bike Network, build upon previous bicycle/pedestrian/greenway planning efforts, and continue the ongoing planning and coordinating efforts which support the provision of bicycle, pedestrian, and greenway facilities. Task 3.5 includes an update of the Bicycle Facilities Map.

#### <u>ANALYSI S</u>

The Bicycle Facilities Map was initially developed in 2010 and updated in 2014 by Kimley-Horn and Associates, Inc. as a user-friendly document that depicts the location of bicycle facilities and presents a color-coded depiction of bicycle suitability ratings based on interaction with traffic. The map will be available to the public free of charge and is intended to serve as a reference to bicyclists for traveling on the roadways of St. Lucie County.

The data collected in 2014 was used as the base data and updated accordingly by the staff in the preparation of the new map. Besides the most recent bicycle facilities information, the new map also includes the basic information about cycling as well as the St. Lucie Bike Share program. The information displayed on the Bicycle Facilities Map is part of the TPO's overall bicycle and pedestrian enhancement goal and can be used for follow-up items such as assessing bicycle and pedestrian connectivity and accessibility.



Helmets are not provided, but officials strongly encourage adults to wear them and Florida law requires cyclists 16 and younger to wear them. 



## Rules of the Road









#### **Use Hand Signals**

Hand signals communicate with motorists what you intend to do; turns require a hand signal for 100 feet beforehand

#### **Ride on the Right**

Ride on the right side of the road, in the same direction as traffic, at a safe distance from the curb and gutter

Never ride against the flow of traffic

#### Stay off the Sidewalks

Sidewalks are designed for pedestrians and not for bicyclists who are traveling faster than walking speeds

Ride where motorists expect you to be

#### **Ride in a Straight Line**

Maintain a car door's width away from parked cars

Avoid dodging in between cars

Watch for parked motorists swinging their doors open

## **Safety Tips**

#### Be Visible & Dress Appropriately

Bicycles riding at night should have a white headlight in the front, visible from at least 500 feet away and a red tail reflector visible in a vehicle's low beams from 300 feet away

Wear bright clothing during the day and reflective clothing at night

Always wear a hard-shell helmet whenever you ride; fit the helmet so the front is just above the top of the eyebrows

#### Two Ways to Turn Left

1) Like a pedestrian, ride straight to the far-side crosswalk and walk your bike across

2) Like a motorist, signal, move into the left lane and turn left

#### Be Alert

Watch for cars pulling out and use caution when approaching driveways and parked cars

Assume that drivers do not see you, and use caution when approaching them
