### 1. Call to Order

Vice Chairman Balcer called the meeting to order at 1:35 pm.

Mr. Buchwald noted that the recent retirement of Marty Sanders had left the office of TAC Chairperson vacant, explaining that the members could conduct an election immediately or wait until the annual TAC elections in January as there was only one more regular meeting scheduled in the intervening months. In response to Mr. DeFronzo's question, Mr. Buchwald explained that an interim chairperson could be elected if the Vice Chairman were unable to attend that meeting. Vice Chairman Balcer indicated that he would likely have to miss the TAC meeting scheduled for November, but members agreed to wait until January to hold the elections.

Mr. Buchwald welcomed Mr. Howard, Sergeant Jones, and Ms. Budhu as new TAC representatives.

### 6. Action Items

**6a. East Midway Road Corridor Study:** Presentation of the draft East Midway Road Corridor Study.

Mr. Buchwald explained that public and local agency input had identified several safety issues pertaining to the segment of Midway Road between U.S. Highway 1 and Indian River Drive, issues that could potentially be exacerbated by the future crossing of the East Coast Greenway/Florida Shared-Use Network (SUN) Trail. He indicated that Kimley-Horn had been engaged to conduct the evaluation of the corridor and introduced Mr. Rairden. Mr. Rairden clarified the boundaries of the segment under study as well as the Study's goals and objectives before presenting information regarding the corridor's traffic patterns, including 85th percentile speeds, crash data, and a capacity analysis. He summarized the features of the programmed SUN Trail project and then enumerated the safety issues that had been identified during the evaluation along with the improvements being recommended to mitigate them. Mr. Rairden then provided an overview of two possible alternatives for the design of the roundabout recommended for the intersection of Midway and Weatherbee Roads.

Mr. Andrews reported that the Fort Pierce Engineering Department had received complaints regarding a right-of-way conflict at the northeast quadrant of the intersection of U.S. Highway 1 and Midway Road caused by simultaneous green arrows for drivers turning right from Midway Road onto U.S. Highway 1 and drivers attempting U-turns on U.S. Highway 1. After consulting his field notes, Mr. Rairden remarked that the traffic signals did not appear to be in conflict but noted that a yield sign might be needed for U-turns on U.S. Highway 1. It was suggested that the conflict might have resulted from a recent upgrade, and Mr. Rairden indicated he would investigate the matter further.

Mr. Dayan commended Mr. Rairden on his presentation, noting that the corridor's safety issues were a matter of concern to many. In response to Mr. Dayan's request for clarification, Mr. Rairden described the Fitch barrier being recommended for installation at the eastern end of Midway Road as being similar in function to a guardrail and able to cushion the impact of a vehicle. Mr. Dayan expressed concern over how the limited embankment at the roadway's terminus might impede the construction of the barrier and questioned whether rumble strips had been considered. Mr. Rairden then explained that the flashing LED stop sign had been recommended for implementation at the intersection of Indian River Drive rather than rumble strips or a

flashing beacon because it was deemed the least disruptive option for nearby residents.

In answer to Sergeant Jones' question, Mr. Rairden explained that the speed data had been obtained by placing four speed detectors along the corridor and avoiding locations near curves where drivers tend to slow down.

Mr. Dayan suggested that the report relabel some of the "Maintenance Recommendations" as "Near-Term Recommendations" to facilitate programming and budgeting efforts. In response to Mr. Buchwald's request for clarification, Mr. Dayan identified \$8,500 to \$10,000 as an appropriate minimum cost threshold for the redesignation.

Mr. DeFronzo commended the presentation's thoroughness but expressed his concern regarding the long-term effectiveness of the rail safety measures recommended for the eastern end of Midway Road, especially considering the anticipated speed of Brightline's trains. Mr. Rairden commented on the importance of combining enforcement efforts with education, citing his experience in Broward County. Mr. DeFronzo remarked on the need for a Safe Systems Approach and suggested that location be given additional consideration in a separate study. Mr. Rairden noted that one possible strategy could be adding gates on both sides of the railroad tracks to more effectively hinder vehicles from crossing when a train is on approach.

Mr. Dayan noted that he had recently given a presentation in St. Lucie Village during which residents expressed concern over the railroad crossings adjacent to Old Dixie Highway. He noted that 11 of the 14 crossings in St. Lucie County would have four gates, and discussion ensued regarding the various rail safety improvements to be implemented.

**6b. Sustainable Transportation Plan:** Presentation of the draft Sustainable Transportation Plan.

Mr. Buchwald invited Ms. Lathou to present the agenda item. She identified the modes of transportation included in the Sustainable Transportation Plan, described how such modes were incorporated into

the TPO's planning efforts, and explained how the SmartMoves 2045 Long Range Transportation Plan provided for the establishment of mobility hubs along I-95. She provided information on Automated, Connected, Electric, and Shared-Use (ACES) vehicles before describing the purpose and scope of the Plan. Ms. Lathou enumerated several components of the mobility hubs and then explained how suitable locations had been identified for the hubs in the TPO area, subsequently outlining the prioritization criteria used to rank the locations. She listed the top 10 locations in St. Lucie County, detailing the concepts for the top four, and concluded with considerations regarding implementation.

Mr. DeFronzo commended the TPO for its proactive mobility planning, commenting on a recent trip to the West Coast during which he observed a great deal of redevelopment with intentional avoidance of parking emphasis on onsite and an multi-mobility options. Mr. Buchwald expounded upon the Plan's land acquisition priorities, explaining how both the process and products of the Transit Development Plan (TDP) Major Update would complement the efforts presently under discussion. He described the stages of the TDP Major Update and announced the upcoming workshops to be conducted as part of the Update's outreach activities. Mr. Covelli then provided an update on the County's microtransit system, describing the program's history, improvements. forthcomina service and Iona-term development.

**6c. 2024 Legislative Priorities:** Review of the proposed Legislative Priorities for the St. Lucie TPO for 2024.

Mr. Buchwald explained that the TPO adopts legislative priorities each year based on the results of the current year's Florida Legislative Session and the legislative priorities of other transportation organizations. He then presented the legislative priorities being recommended for consideration for 2024, which included the Hands-Free Florida handheld device prohibition for drivers, the Moving Florida Forward Forever fuel tax replacement, and the Move Over for People protection for vulnerable road users.

Mr. Dayan indicated his approval of the Priorities. In response to his request for clarification, Mr. Buchwald explained that the proposed Florida fuel tax replacement would consist of an annual fee assessed

for drivers of non-gasoline-powered cars that would be equivalent to the average amount paid in taxes by drivers of traditionally fueled cars.

**6d.** Advanced Air Mobility (AAM) Study Phase 2 Scope of Services: Review of the draft Scope of Services for Phase 2 of the AAM Study.

Mr. Buchwald introduced Advanced Air Mobility (AAM) as a topic and explained that the Study would comprise an AAM demand analysis, use cases evaluation, the identification of at least three suitable destination locations within the TPO area for drone ports along with potential origin locations within the Treasure Coast International (TCI) Airport property, and a visual simulation of the AAM operation to assess its probable impact on the current transportation network in the TPO area. He described the approach to be taken in developing the Study's components, identified the consultant engaged to conduct it, and concluded with the Study's timeline and cost.

**6e.** Congestion Management Process (CMP) Major Update Scope of Services: Review of the CMP Major Update draft Scope of Services.

Mr. Buchwald defined the Congestion Management Process (CMP) and explained that it was required by Federal law for MPOs whose jurisdictions had populations greater than 200,000. He described the TPO's CMP, the last major update of which occurred in 2018, as involving the annual allocation of \$300,000 to \$400,000 toward CMP projects in the TPO's List of Priority Projects (LOPP). Mr. Buchwald then enumerated the various tasks constituting the Major Update as well as the agency partners to be consulted for input, concluding with an identification of the Update's consultant, timeline, and cost.

Mr. Buchwald noted that some of the improvements identified in the East Midway Road Corridor Study would be suitable for inclusion in the CMP List if combined into projects costing \$300,000 to \$400,000.

### **BACKGROUND**

The FY 2023/24 – FY 2027/28 TIP was adopted by the TPO Board on June 7, 2023. Florida Department of Transportation (FDOT) District 4 recently added three (3) new carbon reduction projects to its Work Program and made changes to two (2) existing projects subsequent to the TPO's adoption of the TIP and requests amendments to reflect those changes in the TPO's TIP. In addition, the City of Port St. Lucie requests to add a project to the TPO's TIP to execute a recently-received grant.

### **ANALYSIS**

As summarized in the attached requests from FDOT District 4, the funding source of the Construction phase of the Emerson Avenue Resurfacing Project changed and the total cost increased by almost \$700,000, and the length of the Jenkins Road project increased from 2.128 miles to 5.104 miles due to an initial error in the mile posts with the total cost of the Project Development and Environment (PD&E) phase being increased by about \$2.5 million. The revised TIP pages to reflect this changes are attached.

The following three (3) projects that are included in the TPO's Carbon Reduction Program 2023/24 List of Priority Projects (LOPP) were added to the FDOT's Work Program:

 Installation of new 6-foot-wide sidewalks on both sides of Nebraska Avenue from South Lawnwood Circle to South 13th Street; November 21, 2023 Page 2 of 2

 Resurfacing the multi-use path along Green River Parkway from Walton Road to the Martin County Line; and,

 Improvement of the intersection of Gatlin Boulevard at Savona Boulevard.

The requests from FDOT District 4 and TIP pages to be added to reflect these new projects are attached.

Earlier this year, the City of Port St. Lucie received a \$2 million planning grant from the U.S. Department of Transportation (US DOT) Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Program to design improvements to the Village Green Drive corridor from SE Tiffany Avenue to US Highway 1 which was identified by the TPO as the top priority among 137 corridors in need of Complete Street improvements in the TPO area. The addition of the project to the TPO's TIP and FDOT's State TIP is required to execute the grant. The project fact sheet and the TIP page to be added to reflect the new project are attached.

Because new funding will be added to the TIP that equals the costs of the aforementioned projects, the projects will not impact the fiscal constraint of the TIP. The projects are consistent with the TPO's SmartMoves 2045 Long Range Transportation Plan (LRTP). Therefore, the TIP amendments are consistent with the SmartMoves 2045 LRTP.

### RECOMMENDATION

Because the proposed TIP amendments are consistent with the SmartMoves 2045 LRTP and do not impact the fiscal constraint of the TIP, it is recommended that the proposed TIP amendments be recommended to the TPO Board for adoption.

Pursuant to Part IV – Chapter 5: Statewide and Local Transportation Improvement Programs (STIP and TIP) of the Work Program Instructions, the Florida Department of Transportation (FDOT) requests your processing and approval of the attached modification to the FY 2023/24 – 2027/28 Transportation Improvement Program.

This modification is required because of funding reallocation and/or cost changes and needs to be reflected in the TIP. The project funding is being revised from District Dedicated Revenue (DDR) state funds to STP, Any Area (SA) and ACPR (Protect Grant PGM) federal funds for FY25.

This project is consistent with the goals of the St. Lucie Transportation Planning Organization's Long-Range Transportation Plan. The TIP remains financially constrained. A State Transportation Improvement Program (STIP) Modification is required.



Project Description: The project will plan, design, and conduct community outreach for improvements to approximately 1.65 miles of the Village Green Drive corridor, to include roundabouts, intersection improvements, traffic calming features, 5-foot separated bike lanes, 6- to 10-foot sidewalks, the addition of a median between SE Walton Road and SE Tiffany Avenue, and an enhanced/relocated Wood Stork Trail.

### **BACKGROUND**

The Unified Planning Work Program (UPWP) is the two-year program supported by State and Federal funds of transportation planning activities undertaken by the TPO. The UPWP includes a description of the planning work and resulting products, who will perform the work, timeframes for completion, costs, and funding sources. The UPWP serves as the foundational document for carrying out the 3C (continuing, cooperative, and comprehensive) transportation planning process within the TPO area.

The UPWP enables the TPO to receive funding from the Federal Highway Administration (FHWA), the Federal Transit Administration (FTA), the Florida Commission for the Transportation Disadvantaged (FCTD), and the Florida Department of Transportation (FDOT).

Planning projects are included in the UPWP based on TPO priorities, the need to satisfy State/Federal requirements, and funding constraints. The projects may involve any aspect of surface transportation including roads, transit, bicycle/pedestrian, and the needs of the transportation disadvantaged.

The current UPWP for FY 2022/23 – FY 2023/24 ends on June 30, 2024. Therefore, it is necessary to initiate the development of the UPWP for FY 2024/25 – FY 2025/26 which is for the period from July 2024 through June 2026.

### **ANALYSIS**

An initial discussion of the proposed FY 2024/25 – FY 2025/26 UPWP is requested at this time. The discussion should include the review and/or identification of the planning priorities, tasks, projects, and activities that should comprise the proposed UPWP. The Call for Planning Projects also is being announced to the public through the TPO website/social media and discussions at public meetings.

Through the tasks and activities represented in the UPWP, the TPO continues to apply its priorities in a 3C manner to assist in addressing local needs. The planning priorities proposed to be addressed during FY 2024/25 and FY 2025/26 are substantially the same as the planning priorities of the current UPWP and consist of the following:

- <u>Project Advancement:</u> Support the local agencies in advancing the implementation of projects in the 2045 Long Range Transportation Plan (LRTP), 2045 Regional LRTP, and Transportation Improvement Program (TIP).
- **Previous Planning Efforts:** Build upon and/or implement the results of previous UPWP planning efforts.
- <u>Safety and Security:</u> Provide for the consideration and implementation of projects, strategies, and services that increase the safety and security of the transportation system.
- <u>Performance-Based Multimodal Planning and Programming:</u>
  Continue to conduct performance-based multimodal planning which increases mobility options and ensures the most efficient investment of local, State, and Federal transportation funds by linking investment priorities to the achievement of adopted targets.
- <u>Alternative Transportation Facilities:</u> Support the development and implementation of alternative transportation facilities including sidewalks, bike paths/lanes, and transit, port, airport and ACES (Automated/Connected/Electric/Shared-Use) infrastructure.
- <u>Regional Efforts:</u> Build upon previous efforts and identify new opportunities for regional coordination and collaboration.
- <u>Public Involvement and Education:</u> Continue to enhance public involvement and education.

• <u>Livability and Sustainability:</u> Enhance the livability and sustainability of the local communities.

• <u>Transportation Demand Management:</u> Support efficient travel behaviors.

To address the proposed planning priorities, the following project ideas are proposed to be included in the draft FY 2024/25 – FY 2025/26 UPWP:

- Public Participation Plan Update an update of the TPO's goals, objectives, and strategies regarding public participation. This plan would identify new opportunities to enhance the public's role in transportation decision-making and would help implement the TPO's Title VI Program.
- 2050 LRTP the LRTP describes how the St. Lucie TPO area's multimodal transportation system will evolve over the next 25 years. The meeting of transportation goals will be applied to the prioritization of projects. The LRTP is updated every five years and amended as needed.
- Mobility Data procurement of data, such as travel speeds, times, and reliability and vehicle volumes, from mobile device sources. In addition to supplementing the TPO's Traffic Count Data Management System, the data would assist in implementing recommendations in the TPO's Sustainable Transportation Plan, Electric Vehicle Charging Station Plans, Transportation Connectivity Study, etc.
- Vehicle Sharing Study analysis of methods to provide residents and visitors with short-term access to automobiles. Vehicle sharing, a common first-last mile option at mobility hubs, would support recommendations in the TPO's Sustainable Transportation Plan. A Cornell University study revealed a reduction of 15 personal vehicles for every sharing vehicle; therefore, vehicle sharing also could support recommendations in the TPO's Carbon Reduction Strategy and Congestion Management Process (CMP).
- Autonomous Vehicle (AV) Study Update a status report on self-driving vehicle trends. Because the nationwide focus has shifted to robo-taxis and autonomous freight movement, this study could support recommendations in the TPO's Sustainable Transportation Plan, Advanced Air Mobility Study Phase 2, CMP, etc.
- **Electric Bicycle Study** electric bicycles compete with pedestrians and traditional bicycles for limited roadway space. As ebikes become

more affordable and popular, these conflicts will increase. This study could result in enhancements to the TPO's Walk-Bike Network to make it safer for all users.

In addition to its review by the TPO Advisory Committees, the draft UPWP will be submitted to FDOT and various Federal agencies for their review and comment, and a formal public comment period will be initiated. The TPO Board will consider the draft UPWP for adoption no later than at its April 2024 meeting.

### **BACKGROUND**

A Transit Development Plan (TDP) is required by the Florida Department of Transportation (FDOT) for the receipt of funding through the Public Transit Block Grant Program. A TDP is the public transportation provider's planning, development, and operational guidance document and is based on a 10-year planning horizon. A Major Update is required every five years. Annual updates in the form of progress reports on the 10-Year Implementation Program of the TDP are also required.

In St. Lucie County, the Board of County Commissioners (BOCC) contracts with MV Transportation for public transportation services. A TDP Major Update is adopted by the BOCC after endorsement by the TPO Board.

Task 3.2 of the St. Lucie TPO FY 2022/23 - 2023/24 Unified Planning Work Program (UPWP) includes activities related to the provision of technical and planning assistance to the BOCC to maintain the BOCC's eligibility for the continued receipt of federal and state transit funds. These activities include supporting the TDP Major Update and Annual Progress Reports.

### **ANALYSIS**

As the intent of the TDP Major Update is to reimagine the current transit system in the TPO area, the County Transit Department and consultants embarked on extensive public outreach and data collection efforts. The results of these efforts will be presented.
